Terms and conditions

1 Promoter

2 Competition period

3 Who may and may not enter the competition

3.1 A participant (**you, your**) must:

3.1.1 be a small-business owner who is mandated and an authorised representative of the small business;

3.1.2 be 18 years or older;

3.1.3 live in South Africa;

3.1.4 be a registered member of SimplyBiz;
