

# SimplyBiz® “Get Financially Fit” competition

## Terms and conditions

### 1 Promoter

Nedbank Limited, registration number 1951/000009/06 (we, our, us), runs this competition and we reserve the right to make it available to a select group of Nedbank clients and SimplyBiz members.

### 2 Competition period

The competition starts on 13 March 2025 and ends at midnight on 23 March 2025 (competition period).

### 3 Who may and may not participate in the competition?

- 3.1. Nedbank Small Business Services (SBS) clients (you, your) may enter the competition. An SBS client is a small-business owner or sole proprietor with an annual turnover of up to R30 million and holds one of the following active, FICA-verified accounts (in good standing): Business Pay-as-you-use, a Business Bundle, an SBS Ordinary, a Business Enabler Current or a Startup Bundle Account.
- 3.2. A SimplyBiz member (you, your) may enter the competition. As a SimplyBiz member you need to be a small-business owner or sole proprietor in good standing with an annual turnover of R500 thousand to R30 million.
- 3.3. To qualify, you must also:
  - 3.3.1. have operated your business as owner full time for at least three years.
  - 3.3.2. be 18 years or older.
  - 3.3.3. live in South Africa.
  - 3.3.4. be a registered member of SimplyBiz.
  - 3.3.5. attend the 5-hour “Get Financially Fit” Online Workshop on the 24 March 2025.

  - 3.3.7. and, if you are selected, be available to attend the 10 hours of online coaching with Future Capital between 1 April 2025 and 30 June 2025.
- 3.4. Although meeting the criteria above, the following people may not enter the competition:
  - 3.4.1. our employees (including temporary and contract employees), suppliers and contractors involved in this competition; and
  - 3.4.2. previous competition winners who have won a SimplyBiz competition in the 12 months before the start date of this competition.

### 5 The prize

- 5.1. If you meet the qualifying criteria and enter the competition, you stand a chance to win one of 10 prizes to the value of R20 000 each. The 10 one-hour one-on-one virtual coaching sessions are presented by Future Capital between 1 April 2025 and 30 June 2025.
- 5.2. 8 Nedbank Small Business (SBS clients) and 2 SimplyBiz members will be selected to participate in this 2025 cohort with the Future Capital.
- 5.3. Minimum attendance requirement: you must attend at least 8 of the 10 coaching hours.
- 5.4. Midway attendance check: By Friday, 16 May 2025, if you have not attended at least 5 hours, you will forfeit your prize and be removed from the coaching program.
- 5.5. Rescheduling policy: You may reschedule a one-on-one coaching session up to twice without any penalty. However, if you attempt to reschedule more than twice, you will forfeit that session hour and won't be able to use it later.

- 6.2 The winners will be announced on 26 March 2025 on SimplyBiz social media platforms and via the email address registered on SimplyBiz.
- 6.3 All completed entries received during the competition period that meet the competition requirements will be eligible for entry in the selection.
- 6.4 If there is a dispute, our decision will be final and binding on all aspects of the competition and we will not discuss the matter further.
- 6.5 You cannot transfer the prize or opt for certain elements of the prize. If you do not accept your prize for any reason or do not attend the one-on-one coaching session sessions as stipulated in clause 5, you will forfeit the prize and we will choose another winner, subject to the same terms and conditions at our sole discretion.
